1. **Supersedes.** Solid Waste Fee Policy passed by Resolution # 415-05 July 12, 2005
Resolution # 54-08 January 29, 2008, Resolution #180-08 April 8, 2008,
Resolution # 274-08 May 13, 2008, Resolution # 499-09 December 22, 2009.
2. **Purpose.** To establish a set of fees for the handling of the various classes
of waste identified in Manitoba Conservation License No. 2274 S2 and the Rural
Municipality of St. Clements By-Law No. 2-2008.

These fees would apply to the Rural Municipality of St. Clements Solid
Waste Management Facility on Mile Road 88 and at the Transfer Stations
at Dunning, Clarke Roads, Gull Lake & Grand Marais.

3. **Policy.**

Transfer Stations & Landfill Rates

Landfill Rates

Waste	Resident (Landfill Only)	Non-Resident (Landfill Only)
Mattress or Box Spring	Free	\$ 10.00 each
Sofa	Free	\$ 20.00 each
Chair	Free	\$ 10.00 each

Recyclables and Waste Oil are free of charge – Landfill & Transfer Stations

Agricultural Chemicals Containers – No Charge – Landfill Only

Refrigeration Units **NOT** decommissioned by certified technician – Landfill Only – \$30.00 each

Tipping Fee

Vehicles that are one ton or larger will only be received at the Landfill and the tipping fee shall be \$71.00 per tonne effective January 1, 2017. This fee also applies to all commercial haulers.

Recyclables and Waste Oil are free of charge

Any loads that arrive at the Transfer Stations or Landfill that are not properly tarped or secured to prevent littering shall be charged two (2) times the rate listed or \$5.00, whichever is the greater.

4. **Administration.**

- (a) There shall be no charge to R.M. of St. Clements residents for their own household garbage that arrives at the Solid Waste Management facility on Mile Rd. 88.
- (b) The Transfer Stations will not receive vehicles larger than a pick-up truck except in the case of loads of clean burnables.
- (c) All non-resident fees shall be double excepting when referring to the tonnage rate.
- (d) All requests for fees other than what are identified in this policy will be forwarded to the Landfill Administration Committee who will review the request and make a recommendation to Council, which must be approved by resolution.
