Building a bright future for St. Clements: Council's 2015-18 priorities

The decisions our municipality makes today must also have tomorrow's needs in mind. The RM's 2015-18 Action Plan sets out a strategic direction for the current four-year term of Council. The four-year plan is structured to reflect important trends such as population growth while ensuring the RM is adequately resourced to meet residents' needs and expectations both today and in the future. The RM Action Plan identifies priorities and benchmarks in five key areas:

Transportation and Roads

Residents have consistently identified road improvements and drainage as a top priority. The RM has significantly increased its annual investment in road renewal and maintenance in recent years. During the current term of Council, the RM will continue to increase the annual allocation for road improvements, and invest in areas of the municipality where traffic volumes are increasing and where residents or engineers have identified a distinct need for improvement. The RM's plan continues to improve improve snow clearing, ditch clearing and drainage.



Recreation and Tourism

Increased tourism spending in the RM of St. Clements benefits the entire municipality. Over the next four years the RM will pursue new economic development partnerships and opportunities to market our many tourism amenities, and our municipality as a year-round destination. The RM will also focus on increasing the recreation and leisure options available to residents of all ages in all parts of the municipality.



Waste and Wastewater

This spring, residents in the Old River Road area of the RM will be connected to a new, permanent sewer line, while households in East Selkirk will have wastewater carried to a modern, new-generation lagoon that significantly exceeds the province's new water protection standards. During this term of Council, the RM will continue to explore ways to improve water protection and create new opportunities for residents to connect to water-treatment infrastructure that protects the environment and is convenient for the homeowner. A near-term priority will be to explore grant opportunities to expand the Lockport wastewater treatment plant, which would allow for additional homes to receive sewer service.



The Environment

Both for the sake of today's families and future generations, St. Clements is committed to adopting recognized best practices when it comes to environmental protection, waste reduction and reducing the flow of nutrients into our waterways. During this term of Council, the RM will improve recycling programs to make it even easier for residents to keep recyclables out of the landfill. RM transfer stations will adopt universal standards to improve consistency of service and the RM will explore the possibility of curbside pickup for garbage and recyclables. Council will establish ten-year targets for waste reduction and recycling volumes, and will work with partners to further strengthen protection of our vulnerable rivers and lakes.



Protective Services

From safe roads to emergency preparedness to ensuring a timely response in the event of fire, community safety is a high priority. The RM's Action Plan sets out clear steps to work with partners such as the Partnership of the Manitoba Capital Region as well as neighbouring municipalities to maximize operating efficiencies and further improve emergency response protocols. The RM will also work with regional partners to explore opportunities to improve safety along high-traffic roadways, and will explore ways to improve communication of local by-laws.



Matching municipal revenues with long-term need

St. Clements has long had some of the lowest property taxes and lowest mill rates of all Capital Region municipalities. Council is committed to keeping taxes competitive with neighbouring RMs, while ensuring we have the revenue necessary to invest in core infrastructure such as roads and drainage, and further improve municipal services

from snow clearing to dust control.

Fiscal discipline and transparency are key priorities for the RM. Financial plan hearings are fully open to the public, Council meeting minutes are posted to our website, and budget documents are publicly available.

Similarly, Council is committed to keeping residents informed about future investment priorities and ensuring that annual property tax rates are predictable and tied to important priorities such as roads, recreation and improved services.

Council is committed to a balanced approach to municipal revenues, and over the coming years will seek to increase revenues from multiple streams to increase investments in services and infrastructure while keeping tax increases modest.

A continued focus will be generating revenue from new development via development fees. This

ensures that the costs of new development are not funded by existing homeowners. New developments in our municipality can help fund improvements that benefit all residents.

For the coming year, municipal property taxes will increase by a rate of approximately \$34 per \$100,000 of assessed value. These dollars will directly support the RM in keeping improvements in priorities like road renewal well above historic averages.

The RM will continue to pursue matching grants from the other two levels of government, which allows the RM to invest three dollars in local infrastructure such as roads for every one dollar that comes from the municipality.

The RM will also explore generating additional funds for recreation improvements through federal and provincial grant programs that become available in the lead-up to Canada's 150th anniversary in 2017.
